Launched in 2017 with more than 20 member companies, Access Accelerated is the largest collective industry effort to address inequities in non-communicable disease (NCD) care. Fueled by the belief that all people should have access to quality NCD prevention, treatment and care, we're implementing scalable and sustainable NCD solutions in low- and middle-income countries (LMICs) by helping the public and private sectors work better together.

NCDs like cardiovascular disease, cancer, chronic respiratory disease and diabetes, cause 41 million deaths each year—equivalent to 71% of all deaths globally.<sup>1</sup> The NCD burden is most acutely felt in LMICs, which face the vast majority of premature NCD deaths. Today, people living with NCDs are also at increased risk of severe illness and death from COVID-19 and the pandemic is highlighting the critical need for strong, resilient health systems that are ready to address emerging health crises as well as ongoing population health needs like NCDs.

## A NEW WAY OF WORKING FOR GLOBAL HEALTH SOLUTIONS

We know that no one stakeholder, sector or company can solve the systemic barriers to NCD care alone. Addressing the scale and complexity of the NCD challenge requires deeper and stronger collaboration. We work across borders, sectors and silos to respond to country priorities and meet the needs of people living with or at risk of NCDs.

- Testing models of integrated NCD care at community and primary care levels
- Closing bottlenecks and opening access in the supply chain
- Advancing data-driven decisions through the NCD Navigator, a dynamic mapping of NCD programs that show, for the first time, the scale of NCD programming across a country with real-time data.

VIETNAM



BENEFICIARY POPULATION: 6.1M (2017–2019)\*

- Scaling *Communities for Healthy Vietnam*, a successful hypertension prevention and management pilot that screened 10,000 people in 2019 alone through a people-centered and community-based care model.
